Online Account Application

In this Agreement, the words “you” and “your” mean each person who electronically “signs” by checking the box below that reads, ***“I have read and agree to receive disclosures electronically.”***

“We,” “us,” “our,” and “Credit Union” mean LA Financial Federal Credit Union. By checking the box below, you are confirming that: (1) your system meets the requirements set forth below; (2) you agree to receive Communications (as defined below) from us electronically; (3) you are able to access and print or store information presented at this website or that you receive from us via email; and (4) you have downloaded or printed a copy of this Agreement for your records.

In addition, by checking the box below, you agree that:

1. Any notice, record, disclosure, or other type of information that is provided by us to you in connection with using our online account application service (“Service”), the account(s) that you may open using the Service, agreements concerning new or improved products and services, change-in-terms notices, fee and transaction information, other notices, check images, and other account information (“Communications”), may be provided to you by us electronically, on an ongoing basis, by posting the information for you to view at our website, www.lafinancial.org or www.hccu.org, or by sending it to you by e-mail. If we post the information on our website, we will notify you via email where the updated information resides on our website.
2. We will not be obligated to provide any Communication to you in paper form unless you specifically request us to do so.
3. You may obtain a copy of any Communication by contacting us at www.lafinancial.org or www.hccu.org, or by calling us at 800.894.1200 (See our current Schedule of Fees and Charges on our [disclosure page](#) for the related expense). You also can withdraw your consent to receive Communications in electronic format by contacting us and you may ask that they be sent to you in paper or non-electronic form. We may elect to terminate some or all of your electronic banking services if you choose to receive Communications in paper or non-electronic form.
4. You agree to provide us with your current e-mail address for notices at the email address or phone number indicated above. If your e-mail address changes, you must provide us with your current e-mail address using our online banking service.
5. If any of your accounts are joint accounts, you certify that you are the primary accountholder of such accounts and that your acceptance of these terms and conditions has been authorized by each of the accountholders. All joint owners on your accounts are legally bound by the terms and conditions of this Agreement.
